I understand that my completing an application form allows Jacaranda Finance Pty Ltd (Jacaranda Finance) to collect, use, hold and disclose my information as outlined in the Jacaranda Finance Privacy Policy, which I declare that I have read and understood.

Collection of information

I consent to Jacaranda Finance collecting personal and credit information from me. I understand that if I do not provide all information that is requested from me Jacaranda Finance may be unable to provide me with their financial services. I also understand that if any of my personal information should change, such as residential address, phone number, email address, etc, it is my responsibility to advise Jacaranda Finance of this. Exchange of Information with Credit Reporting Bodies

I give my expressed and informed consent to Jacaranda Finance exchanging my personal and credit information with credit reporting bodies.

I consent to your verification agent(s) acting as a nominated intermediary in accordance with Australian Privacy Principles. I consent to the use by third parties of the results of any verification checks on my identity for the purposes of monitoring and improving their verification services. I understand that the credit reporting body will attempt to match the information I have provided with the information they have access to, including their credit file header database, and provide an assessment. I understand as part of the identity verification process;

- the information will be subject to an Information Match Request in relation to relevant Official Record Holder information;
- that the Information Match Request, the Information Match Result and other Information Match Data and our access to and use of the document Verification Service may involve the use of third-party systems and services; and
- that information provided to or by you in or from Australia will be transmitted to New Zealand or vice versa.

I understand that if no match is found between the details I provide, and the information held by the credit reporting body, Jacaranda Finance will notify me of this. I also understand that if no match is found, I will have the opportunity to provide further documentation to verify my identity. I understand that if Jacaranda Finance is unable to verify my identity, Jacaranda Finance will be unable to provide me with financial services.
